General attestation of documents like photocopy of Bangladesh passport, photograph, application for police clearance certificate, applications for opening a bank account in Bangladesh (Each application)	15.00
‘No Visa Required...’ stamp in Australian/ New Zealand or other eligible citizen (For first time or transfer)	70.00
